The law of Social Security No arranges 105 of the 2008, in his article 4 that the Regimen of Social Work protects to any unapt person to work that he lack relatives ready to help him, likewise he establishes 109 in the article that protection is conceded by means of monetary social benefits, species and services.

Of monetary social benefits: He establishes the concession of these social benefits, than according to his nature they can be temporary or eventual. In like manner, it becomes regulated than entity exceptional cases, the Department Of Labor and Social Security can concede monetary temporary exceptional social benefits of the Regimen of Social Work in superior quantities to the restrained in the established scale.

The ones that are granted when the person or family nucleus, for exceptional and justified reasons, present an emerging situation, are monetary eventual social benefits he considers emerging, when he lacks family and revenue support to assume the immediate basic expenses for maintenance to children, bigger adults, people with disability, gravely sick persons or another payments that they consider themselves unpostponable.

The ones that are granted for the term are monetary temporary social benefits of to a year, when it is prepared for that the situation of the family nucleus that originated his concession, lingers on in the time.

The quantity of monetary temporary social benefits is fixed taking into account the scale established, conditioned to members's quantity of the family nucleus and the protective need, so that it will have to be checked her:

Incapacity of the members of the family nucleus to sit up to the job, motivated for situations of health, disability or another causes that they justify it.

Insufficiency of revenue to assume the basic expenses.

Scarcity of relatives forced ready to give help.

## Something that it must taste:

One or more people that reside in a same domicile are understood for family nucleus, existing among them, in addition to the family, affinity or cohabitation relation, common participation in the economy of the aforementioned nucleus.

He determines the protective need when the incapacity of the members of the family nucleus to sit up to the job is demonstrated, motivated for situations of health, disability or another causes that they justify it, verify him insufficiencies of revenue to assume the nutrition, medications, the payment of basic services and the scarcity of relatives forced to give help.

The protective need of a family nucleus can be presented, by the very stakeholders, social workers, polities, of masses and social, institutions, delegates of circumscriptions, or someone else that thus he consider him, to Trabajo Municipal's Direction for his attention and evaluation.
